A facts finding committee has been constituted vide MoHFW order no. A 28015/31/2019-H-I (FTS-3209369) dated 05-11-2019 as under;

The Terms of References of the committee are as under;

- Stock taking of all the equipment of the 3 Hospitals i.e. VMMC & Safdarjung Hospital, ABVIMS & Dr. RML Hospital and LHMC & Associated Hospitals (Smt. Sucheta Kriplani Hospital and Kalawati Saran Children's Hospital).
- ii. To examine the practice of procurement of different equipment and identifying lacunae therein and to suggest improvements in the procurement process.
- iii. To examine the practice of annual maintenance contracts in respect of different equipment and identifying lacunae therein and to suggest improvements with special reference to expediting the process of repair in the minimum possible time.
- iv. To examine he necessity of condemnation of obsolete equipment and if so, identify such equipment for the purpose.
- v. The deliverables expected from the Committee would be as follows:
 - a. Up-to-date lists of equipment in respect of each of the aforesaid hospitals.

- b. Up-to-date lists of non-functional equipment in each of the aforesaid hospitals.
- c. List of those equipment which are ripe for condemnation/disposal along with the book value of each equipment.
- d. Revising/Devising Standard Operating procedure to be followed for procurement, for executing Annual Maintenance Contracts and for disposal of obsolete/faulty equipment, specific to medical sector and in Indian scenario.
- e. Examine existing Standard Operating procedure for procurement, AMC and disposal of equipment.

The committee is expected to submit its report within 2 months and the inspection of the hospitals has been scheduled from the 3rd week of November 2019 as per convenience. All the departments of LHMC & Smt. S. K. Hospital, New Delhi are hereby required to maintain all the documents, files & record as per deliverables for the committee. The departments will be directly responsible for noncompliance of the above directions.
